

INTERNATIONAL LEATHERBOY® 2007 Preliminaries

Contestant Qualifications

Each contestant in the *International Leatherboy®* contest and preliminary regional and local contests:

- a) must be at least twenty-one years old;
- b) must be biologically male from birth and identify as a boy in the leather community;
- c) must be of same-sex orientation;
- d) must have a demonstrated interest in leather, BDSM or fetishes, as determined by the judging panel;
- e) must be a resident of the DCI region that he represents, unless an exception has been granted by DCI after consultation with the sponsors of the regions in which the contestant wishes to compete and in which the contestant resides;
- f) must not hold a current leather title earned in a non-DCI leather title contest;
- g) must agree to appear onstage wearing appropriate leather and fetish gear and perform an onstage leather sexual fantasy of an explicit nature (while conforming with local regulations, if any, pertaining to nudity and obscenity);
- h) must own all leather clothing worn onstage during the contest, except for clothing and props used in the fantasy portion;
- i) must agree to represent his *Leatherboy®* title, if he wins, throughout his title year and refrain from competing in any other leather title contest until the conclusion of his *Leatherboy®* title year;
- j) must agree to advance to the next contest within the *International Leatherboy®* title system if he wins at the local or regional level;
- k) must agree to permit on-stage photographs to be taken of him for the use on the *International LeatherSIR and Leatherboy®* web site.
- l) must agree to refrain from posing for explicit photographs to be published in any print or electronic media without the consent of DCI.

Regional *Leatherboy®* titleholders shall create and donate a basket of leather paraphernalia and regional items for auction in the *International LeatherSIR and Leatherboy®* Basket Auction to raise funds for the *International LeatherSIR and Leatherboy®* Travel Fund.

Local contestants may be sponsored by a club or business, or self-sponsored. *International Leatherboy®* contestants shall be restricted to regional contestants who have placed first in their regional *Leatherboy®* contests unless an exception has been granted by DCI.

Winners of the Regional Leatherboy contests must arrive in **Dallas** no later than 12:00 noon, Thursday, October 4, 2007 and appear in person for all of the scheduled events during ILS/b 2007 Weekend through Sunday, October 7, 2007.

WHAT IS EXPECTED OF TITLEHOLDERS

Leatherboys® must conduct themselves in proper leather protocol and dress at all times during their title year. Flagrant violation of this policy may result in forfeiture of the title. *Leatherboys®* may travel to as many DCI events as feasible during their title year. Regional *Leatherboys®* must compete in ILS/b 2007 and appear in their regional contests at the conclusion of their title years to award the next year's winners. Regional *Leatherboys®* may be required to organize or participate in fundraisers for their region's travel fund and contest expenses. Local and regional *Leatherboys®* are strongly encouraged to organize and participate in fundraisers for charitable causes as well.

INTERNATIONAL LEATHERBOY® 2007 Preliminaries

Judging Method

Leatherboy® contestants shall be scored by panel of judges using an Olympic scoring system in the categories and points outlined below:

- a) Interview - maximum 300 points (up to 60 points per judge) - Each contestant will meet with the judging panel offstage prior to the contest to answer the judges' questions about the contestant's interest in leather, BDSM and fetishes, knowledge, servitude and interaction with their regional **LeatherSIR®** and the community, and willingness and ability to represent the title.
- b) Introduction/Leatherboy® Image - maximum 200 points (up to 40 points per judge) - Each contestant will appear onstage to introduce himself to the audience and briefly describe his background or interest in the leather community, while wearing the attire that best represents his image of a **Leatherboy®**. It is not encouraged to expound on a political "platform." The onstage Introduction shall be no longer than two (2) minutes.
- c) Fantasy(regional and local contests only) - maximum 300 points (up to 60 points per judge) - Each contestant will perform an onstage leather sexual fantasy that conforms to the region's assigned "theme." The onstage Fantasy shall be no longer than five (5) minutes. The Mid-Atlantic Regional theme for 2007 is "Head Space".
- d) Physique/Jockstrap - maximum 200 points (up to 40 points per judge) - Each contestant shall appear onstage in body-revealing attire which emphasizes his best physical feature.

The time restrictions shall be strictly enforced for each of these categories. The time restrictions and allocation of points may be modified with prior notice to the contestants and regional sponsors. At the international level, the regional **Leatherboy®** contestants do not perform an onstage fantasy. Instead, **LeatherSIR®** contestants are required to include their regional **Leatherboys®** in their fantasies, and the points are allocated as follows: Interview – maximum 400 points (80 points per judge); Introduction/Leatherboy Image – maximum 300 points (60 points per judge); Physique/Jockstrap – maximum 300 points (60 points per judge). Points may be deducted from the **LeatherSIR's** fantasy score if there is not meaningful interaction between the **LeatherSIR®** and **Leatherboy®** during the fantasy.

In the Olympic scoring system, the highest and lowest of the judges' scores will be discarded in each scoring category and the remaining scores will be summed. The contestant whose aggregate score is highest will be declared as the winner. The contestant whose score is second highest will be declared as the first runner-up. In the event of a tie under the Olympic scoring system, the non-olympic scores will be used to determine the winner. If both the Olympic and non-olympic scores are tied, the scores of an alternate judge may be used to break the tie.

A winner and first runner-up shall be selected for the **Leatherboy®** contest. In the event of any dispute regarding the tallying of a contest, DCI shall assist the contest sponsor to resolve the dispute, but the contest sponsor shall make the final determination of the winners.

In addition to the winners and runners-up, the contest sponsor may award a Brotherhood award to the most congenial **LeatherSIR®** or **Leatherboy®** contestant, selected by a secret poll of the contestants, den daddies and den boys. The Tallymaster shall tally the Brotherhood ballots.

FANTASY THEMES

Each region has been assigned a different "theme". The themes are intended to inspire contestants' onstage fantasies that are appropriate to the image of masculine leather sexuality and to showcase the diversity of leather interests. The themes are not intended to be restrictive. **Leatherboy®** contestants are encouraged to be creative and expand the boundaries of their themes. The "Head Space" theme for the Mid-Atlantic region for the year 2007 includes (but is not limited to): mind-control, hypnotism, human "puppy" play, and any other type of situation that would cause the leatherboy to be in a different frame of mind or "altered state" during the scene.

Leatherboy® contestants shall be prohibited from having private meetings or engaging in sexual activity or leather scene play with the judges prior to the announcement of the results. Any behavior that might create even the appearance of bias will be brought to the attention of the head judge, who will decide if the disqualification of the judge and/or contestant is warranted. To avoid accidental violation of this policy, all contestants and judges should display their identification badges at all contest events.
